
# NATIONAL FORESTRY POLICY AND DEVELOPMENT STRATEGY (NFPS) FOR ROMANIA (2001-2010)

#### Introduction

Forests affect our lives at many levels; economic, social and environmental. International concern for the protection of the environment and an awareness of forests in this context has been increasing in recent years. The world's forests play an essential role in life and economic development, in the protection of ecosystems, freshwater, biodiversity and genetic material and in climate balance. Their protection, sustainable management and development has therefore become an international issue.

Romania's forests constitute a valuable natural and renewable resource with the potential to contribute positively to national economic development and the well being of Romanian citizens. Forests cover approximately 27% of Romania's land area and include some of the last and largest tracts of natural and virgin old-growth forests still remaining in Europe.

Forestry is neither a stand-alone nor a self-contained sector. It has linkages with agriculture, rural development, industry, trade and the protection of the environment. Due to of its multi-faceted nature and interaction with the environment and other areas of economic and social importance, planning for the development of forestry at national level must be both comprehensive and integrated.

This National Forestry Policy and Development Strategy (NFPS) has been developed through an open, consultative and participatory process, involving stakeholders from all related sectors (Figure

1). It represents a comprehensive and integrated framework for the sustainable development of Romania's forestry sector.

The NFPS, in addition to defining overall forestry policy at national level:

- > Sets out and prioritizes a series of specific strategic actions to achieve on policy goals; and
- ➤ Provides the basis for the co-ordinated and sustainable development of the sector.

#### **Overall Goal**

The overall goal of the forestry policy is:

"The development of the forestry sector to increase its contribution to the improvement in the quality of life, based on the sustainable management of the forest resource."

#### **Overall Strategic Objectives**

The achievement of this overall goal together with specific sectoral policies for silviculture / management, logging / wood processing, marketing and research / education, is supported by three overall strategic objectives at Governmental level:

- 1. The development of an institutional framework to implement in a coherent and sustainable fashion, the development strategy for the forestry sector;
- 2. The development of the legislative framework for the forestry sector; and
- 3. The encouragement of the association of private forest owners, logging, transport and processing companies in professional or patronal organizations.

### **Sectoral Policies**

There are four principal policy statements encompassing the sustainable development of the forestry sector:

### A) Silviculture / Management:

<u>Policy</u>: To ensure forest management according to the principles of sustainable management of natural resources, taking into account the diversity of forest land ownership.

#### B) Logging, Transport and Wood Processing

<u>Policy</u>: The better utilization of wood resources through the integration of logging and wood processing activities within the concept of sustainable management of the natural resource


### C) Marketing

<u>Policy</u>: The market development of forestry resources, in particular high added value products to achieve the sustainable development of the sector.

#### D) Research, Education and Career Development

<u>Policy</u>: The development of scientific research and education for the sustainable management of forests, the economic development of the forestry sector and the improvement in the quality of the environment at national, regional and global levels.

To achieve on policy aims for each of the four sectors, specific strategic objectives and actions are defined. These are prioritized and the main organization(s) responsible for implementation together with the agreed supporting partner organization(s) are identified. This partnership type approach towards collective responsibility for achievement of objectives will facilitate successful implementation and achievement of policy goals.



# NATIONAL FOREST POLICY AND DEVELOPMENT STRATEGY (NFPS) FOR ROMANIA (2001-2010)

**OVERALL GOAL** for the forestry sector

The development of the forestry sector to increase its contribution to the improvement in the quality of life, based on the sustainable management of the forest <u>resource</u>.

#### STRATEGIC OBJECTIVES at governmental level:

- <u>The</u> development of an institutional framework to implement in a coherent and sustainable fashion the development strategy for the forestry sector.
- The development of the legislative framework for the forestry sector.
- 1. Review and harmonization of existing legislation relating to the sector;
- 2. Harmonization of national legislation with EU legislation, international agreements and conventions to which Romania is a signatory;
- 3. Modify and frame the existing legislative framework to support and promote the market economy mechanisms and instruments in the sector;
- 4. Review and promotion of the legislative framework for the management of the national forest fund through forest districts, irrespective of the type of ownership;
- 5. Modify and frame the legislative framework relating to harvesting and wood processing activities to meet the requirements of environmental protection and conservation;
- 6. Improvement of legislation relating to forest land restitution and the promotion of regulations to avoid over-fragmentation of the private forestry fund through sale and succession;
- 7. Promotion of legislative framework (based on a participatory process), regarding:
  - Incentives for forest land owners to ensure the stability and improvement in the functional efficiency of forest ecosystems; and
  - Management of protected areas.
- 8. Modify and frame existing regulations to <u>provide</u> incentives to all land owners for the conservation of game and fish species;
- 9. Elaboration and promotion of financial and compensatory mechanisms targeted at biodiversity conservation activities and the management of protected areas;
- 10. Drafting and passing of specific norms and regulations for companies involved in the forestry sector, to facilitate their efficient (financial and operational) performance; and
- 11. Drafting and passing of regulations to provide incentives for the beneficiaries of research activities and for those who invest in research and development activities.
- The encouragement of the association of private forest owners, logging, transport and processing companies in professional or patronal organisations.
